<b>Independent Functioning</b>	Requires no services or assistance beyond what is normally provided to all students-Self care skills consistent with peers	Requires simple adaptations: prompts and strategies to foster independence, follows peer teacher modeling of task	Requires modified adaptations/strategies; creating overall independence or school and social situations- visual prompting	Requires extensive modifications: implementing and supervising independent academic and social experience	Requires alternative curriculum and substantial modifications; practice independent living skills staff complete self-care
<b>Special Health Care</b>	Requires no services or assistance beyond what is normally provided to all students-Self care consistent with peers	Requires simple adaptations; hygiene/grooming assistance, monitoring medical needs	Requires moderate adaptations ; creating toileting plans, hygiene plans, eating plans	Requires extensive implementation of toileting/medication plans, supervision of eating and medical needs	Requires constant attention to medical needs; supervision for medical/safety reasons assistance with feeding and self-care
<b>Communication (Oral or Written)</b>	Requires no services or assistance beyond that which is normally provided to all students- Communicates wants and needs	Requires simple adaptations to curriculum or leaning environment; prompting rephrasing, occassional assitive technology	Requires modified curriculum/learning environment: social stories, visual schedules, frequent assistive technology	Requires alternative curriculum; frequent social stories, visuals, alternate communication systems, daily assistive technology	Requires altenative curriculum modifications: use of alternative communication systems
